#### Concerning deductions for donations



Membership fees are considered to be contributions to our foundation based on Japanese tax law which allows the amount to be applied towards preferential tax treatment, and when doing final tax returns (kakutei shinkoku) membership fees are accepted as deductions on income taxes (shotokuzei) or corporation taxes (houjinzei). Additionally, Kyoto Prefecture and Kyoto City residents can claim a deduction in the amount contributed on their Individual Inhabitant Tax (kojin jyumin-zei) for the previous year. For corporations, it is acceptable to use general contributions in calculating financial losses.

A receipt of financial contribution will be sent after recieving the application which is necessary in order to qualify for a tax deduction.
